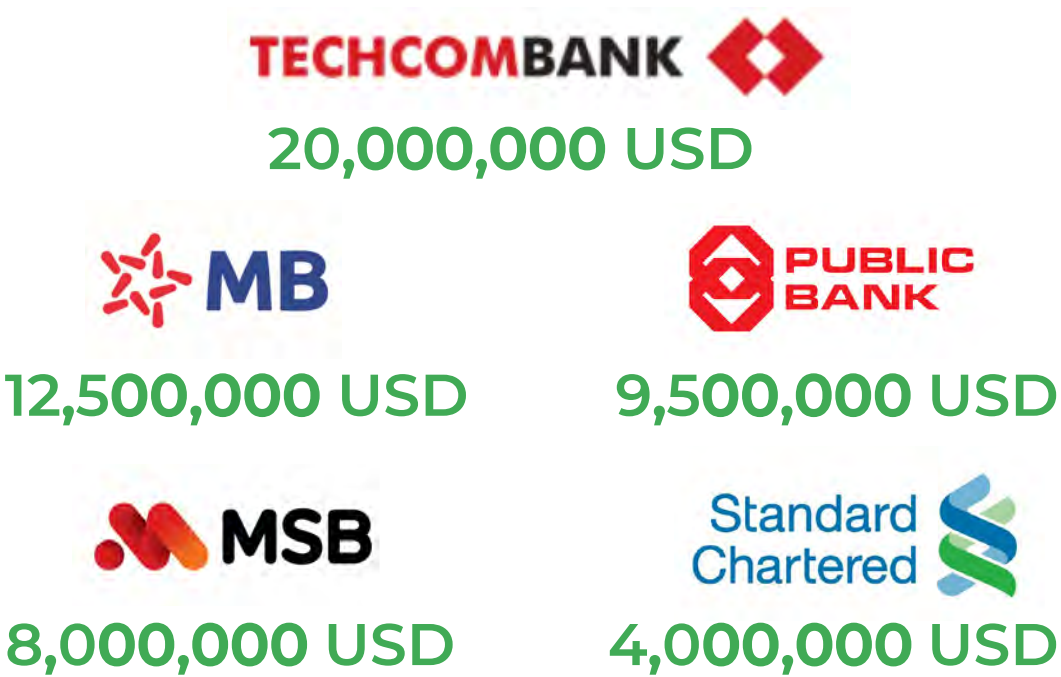

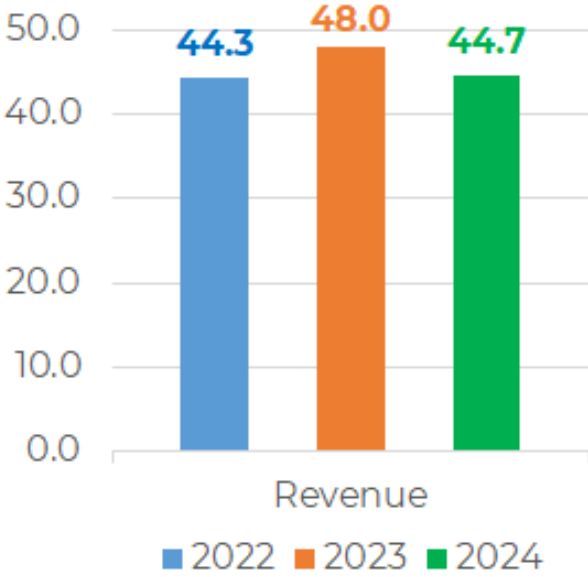

Process

BIM and 3D REVIT

BIM (Building Information Management) represents an advanced process widely applied in the construction industry, based on 3D digital models integrated throughout the full lifecycle of design, infrastructure, and building execution. Unlike traditional 2D or basic 3D drawings, BIM models are intelligent systems embedded with comprehensive data continuously updated as projects evolve.

Recognizing the advantages of BIM in project design and management, Thang Tien Engineering has made significant investments in digital infrastructure, human resources, and training over the past six years to fully implement this technology. BIM adoption streamlines the design-build-management cycle and has been effectively applied in major projects such as Aqua Central Residences and Mall, Grand Mercure 5-Star Hotel, Lotte Mall West Lake Hanoi, Taisei Square Hanoi, Saint-Gobain Gypsum Board Plant, FM Logistic Distribution Center, and the Nitori Furniture Manufacturing Plant in Vinh Phuc.



CHARACTERISTICS

BIM technology is transforming how buildings and infrastructure are designed and operated. It enhances workflows, increases design efficiency, and optimizes performance throughout the entire project lifecycle. Essentially, BIM functions as a comprehensive 3D model that includes all structural and technical elements such as brickwork, plastering, roofing, lighting, interior finishes, mechanical, and electrical systems defined in detail within the model.

All individuals and organizations involved in design and construction can utilize BIM data to analyze costs, schedules, material quantities, and spatial layouts. The entire process relies on continuous, synchronized, and accurate information sharing from the initial concept to final completion. Because of this, BIM is widely recognized as “Building Information Management.”

Centralized and consistent data enables seamless collaboration throughout the project. Every update is automatically synchronized with precision. BIM can detect potential clashes (e.g., piping intersecting structural beams), generate 2D drawings directly from the model, identify design conflicts, and support coordination between disciplines architecture, structure, MEP, fire protection, and construction.
